Terms and Conditions related to Tender for purchase of books

1. The participators have valid Regd. No.TIN/SRIN/PAN/GST (All tax related documents).
2. The firm shall be selected basing upon maximum discount rate wide publication covered, no of titles to be displayed and timely delivery offered by them.
3. FOR Central Library, North Orissa University, Takatpur, Baripada, Mayurbhanj.
4. Books as per list are to be delivered within 7 days from the date of receipt of the order.
5. Free packing and forwarding by the supplying firm.
6. Bills in triplicate be furnished with the books during the time of supply.
7. The copy of the current price list and original catalogue is required to submit during the time of display by the supplier for selection and approval of books.
8. Before issue of purchase order, the party shall deposit EMD 5% of the total cost of the books in the shape of BD drawn in favour of Comptroller of Finance, North Orissa University payable at Baripada.
9. For non-supply of books as per order, terms & condition the EMD of the said firm shall be forfeited and order will stand cancelled.
10. Payment will be made after completion of all formalities as soon as possible.
11. No TA/DA/Transport cost/Accommodation etc. shall be provided by the University for the purpose.
12. The University will purchase 60% of the Reference books and 40% of the Textbooks on the following subjects of post-graduate departments and others. The firms are informed to display the books accordingly.
