TERMS AND CONDITIONS

Essential Qualifications for the post of Associate Professor:

Eligibility

- i. A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- ii. A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- iii. A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant professor in a university, College or Accredited Research institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy-five (75) as per the criteria given in Appendix II, Table 2 of the UGC Regulation 2018.

Essential Qualifications for the post of Associate Professor of Int. B.Ed. - M.Ed.

- i. Postgraduate degree in Physical Science/Mathematics/Social Sciences/language/commerce with minimum 55% marks (or an equivalent grade in a point scale wherever grading is followed).
- ii. Postgraduate degree in Education (M. Ed or M.A. Education) with minimum 55% marks.
- iii. Ph.D. degree in Education or in the discipline relevant to the area of Specialisation.
- iv. A minimum of eight years of experience of teaching and/or research in an academic /research position equivalent to that of Assistant professor in a University, College or Accredited Research institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy-five (75) as per the criteria given in Appendix II, Table 2 of the UGC Regulation 2018.

Relaxation of Marks:

A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy,

leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

SERVICE CONDITIONS

- a. The University shall be governed by the rules and regulations of the Higher Education Department, Government of Odisha, as amended from time to time.
- b. Appointment to the posts shall be made as per the Odisha University first statute -1990 and Odisha Universities Act with amendments from time to time. Pay and allowances shall be as sanctioned by the Government of Odisha from time to time.
- c. Minimum qualifications and selection for direct recruitment as Assistant Professor shall be as per UGC Notification No.F.1-2/2017 (ES/PS) dated 18th July 2018 and subsequent amendments from time to time.
- d. Retirement age and other conditions shall be as per Government norms. Presently, the superannuation age is 60 years.
- e. Reservation of posts will be according to Govt. of Odisha norms.
- f. Selection Committee shall be as per UGC norms notification 18th July 2018 and Odisha Universities statute /Act as amended from time to time and the pay structure shall be as approved by Higher Education Department, Govt. of Odisha.

Candidates must submit documentary proof in support of minimum years of teaching experience in a University/College as Assistant Professor, Associate Professor, or Professor, and/or research experience at an equivalent level in University/National-level institutions, along with proof of successfully guiding doctoral candidates, in accordance with the latest UGC guidelines.
3. Only matriculation/SSC certificate/Pass Certificate issued by the concerned educational board will be considered as Proof of date of birth. No other document will be accepted for verification of date of birth.
4. Candidates belonging to SC/ST/SEBC categories must submit valid caste certificates as per the guidelines and certificate format of the Govt. of Odisha category by birth are required to enclose with their applications, copies of the relevant caste/Tribe certificates issued by the competent authority in the prescribed form. 7. (a) The period spent acquiring M.Phil. / Ph.D. shall not be considered as research experience.




