

MSCBU invites sealed offers bidding for above mentioned items at **Maharaja Sriram Chandra Bhanja Deo University, Baripada**. Interested parties may download the Tender Document from University Website "<https://www.nou.nic.in/tender.htm>"

1. **Last date for Submission of Bids:** 29.03.2025 at 05:00 PM
2. **Opening of Technical Bid Date:** 02.04.2025 at 11:30 AM
3. **Opening of Financial Bid Date:** 04.04.2025 at 11:30 AM
4. **Tender fee (Non-Refundable):** Rs.3000/-(Rupees Three Thousand) in the form of a DD/Pay Order favouring **The Comptroller of Finance, MSCBU, Takatpur payable at Baripada**.
5. **Earnest Money Deposit:** The Bidder shall submit their quotes along with EMD at 2% of the Bid cost. EMD should be in the form of DD favouring **The Comptroller of Finance, Maharaja Sriram Chandra Bhanja Deo University, Takatpur, Baripada-751003 payable at Baripada**. This Bank Guarantee should be valid for minimum 90 Days from the date of opening.

Clause 1: Terms and Conditions

1. Efficiency & running cost, Durability of material, Reliability & guarantee of quality, Technical qualifications, financial standings and general reputations of the supplier.
2. The bidder must have valid GST Registration number.
3. The rate quoted shall remain valid ordinarily during the financial year. However, MSCB University reserves the right to go in form fresh tenders on the basis of the market condition.
4. Financial bids will be considered only after fulfilling the technical bids.
5. Rate quoted should be inclusive of all taxes and charges including transportation.
6. The Quantity tendered for is tentative and may change as per the requirement of MSCB University.
7. The payment will be released only after supply of the items as per Purchase Order at MSCB University and inspection of the same by the authority.
8. MSCB University reserves the right to deduct statutory dues/taxes if any due for deduction as per government rules.
9. This University reserves the right to reject any of the supplied items that doesn't match the specifications mentioned in this tender or are damaged. The bidder must immediately replace the same at no extra cost.

10. The dealer has to submit a performance security in form of Bank Guarantee from any nationalised bank amounting to 2% of the bid value, valid for a period of 12 months from the date of supply of items. Performance security to be furnished along with the bills of the supplied items.
11. Delivery should be made within 3 weeks from the date of receiving the order failing which penalty @1% of the order will be imposed for each week of delay or cancellation of purchase order and forfeiture of E.M.D.

6. EMD at 2% of the Total bid cost in form of a separate Bank draft in favour of "**The Comptroller of Finance, Maharaja Sriram Chandra Bhanja Deo University, Takatpur, Baripada-751003 payable at Baripada**"
7. A signed undertaking to the effect that the Agency has not been blacklisted by any of the Departments/Organizations of the Government of India/Government of Odisha and no criminal case is pending against the said firm/agency/proprietor (As per Annexure IV (Undertaking)).
8. Undertaking showing that Terms and Conditions of the tender has been duly accepted with stamp of the prospective bidder.
9. **Each page of the tender document be signed and stamped by the authorized signatory and submitted along with technical bid.**
10. Bids without Tender document cost/E.M.D shall be rejected summarily.

Clause 3: Procedure of Submission of BIDs

1. Bids are to be submitted in two bid system. i.e. Technical Bid and Financial Bid.
2. Technical Bid alongwith all the requisite documents as mentioned at Clause 2 of this document is to be submitted in the format prescribed under Annexure I. All the documents are to be placed inside a sealed envelope marked as "Technical bid".
3. Financial bid to be submitted as per Annexure III and to be placed inside a separate sealed envelope marked as "Financial bid".
4. Both the envelopes containing Financial Bid and Technical Bid are to be placed inside another Envelope super scribed "**Tender for Printing and Supply of Pre-Printed Original Diploma Certificate**" and submitted through Speed Post / Regd. Post at the Office of the Registrar, Maharaja Sriram Chandra Bhanja Deo University, Sriram Chandra Vihar, Takatpur, Baripada-757003 by 05:00 PM on or before 29.03.2025. Incomplete and Late bids shall be rejected summarily.

 - II. If a bidder withdraws his bid during the period of bid validity specified in the terms and conditions of tender.
 - III. In case of any lapse/default in honouring of the terms and conditions at any stage after submission of tender.
